

Livery Terms and Conditions

1. Definitions

Contract	Agreed conditions of the livery
Customer / Client	Person(s) with whom contract for livery entered by Yard
Horse	Horse or Pony to be kept on yard
Livery	The service provided by the yard
Proprietors	The owners of The Daimler Foundation
Yard	Livery at The Daimler Foundation

2. Contract

This contract is personal to you and not transferable.

The contract may be revoked at any time at the discretion of either the Yard or the Customer through giving one full month's notice in writing. Full payment for that month must be made whether the Horse remains at, or is removed from, the Yard. There will be no exceptions to this, and ***you should only sign this contract if you accept this clause.***

The Yard will allocate stables and grazing to the Horses. Where possible, the special needs and wishes of the Customer will be accommodated.

The Customer will obtain the Proprietors permission before installing any fittings to the allocated stabling. The Yard will carry out all repairs and alterations. Damages caused by the Customer or Customers Horse, over and above fair wear and tear, will be charged to the customer at cost price.

Maintenance of grazing and fencing is the responsibility of the Yard. Rotation of grazing and restriction of turnout will be at the discretion of the Yard. Any damages to fencing or sight of poisonous plants must be reported to the Proprietor immediately.

Please ensure your horse has up to date vaccinations and Strangles tested. You **must** provide this documentation before your Horse is transported to the Yard.

Your Horse will be wormed upon arrival and all Customers will be expected to comply with the Yard worming schedule. It will be the responsibility of the Customer to ensure their Horse has been wormed.

3. Livery Packages and Fees

The provision of stabling and grazing on a rental basis is undertaken by the Yard for remuneration. Any special needs or requirements must be notified in writing. You will have access to the indoor collecting ring when it is not in use for Riding School lessons, and full access to the outdoor sand arena and grass arenas, except during shows which have booked and are using the outdoor arenas. You can use the 'Trail Ride' through the forest, however, must book in advance. There is **no access** to the Main Arena unless competing or prior permission has been granted, anyone caught not following this rule may be asked to leave the premise and contract revoked.

All liversies will have access to a shared lockable tack storage room.

Yard opening hours are between:

Monday 9am-5pm

Friday 9am-8pm

Tuesday	9am-8pm	Saturday	9am-8pm
Wednesday	9am-8pm	Sunday	9am-6pm
Thursday	9am-8pm		

Please note that we expect you to finish riding and be off the Yard by these times.

Owners attending shows or visiting a sick Horse may do so out-with these times with prior permission granted.

3.1 Full Livery

Cost: £110.00 p/week

The Full Livery Package offered by The Daimler Foundation includes horses looked after 7 days per week. This package includes:

- Mucking Out
- Turning out/in (Weather permissible)
- Haylage
- 1 bale of shavings per week
- Standard feed.
- Pick out feet each evening
- Use of Wash Bay (Solarium not included)

3.2 Assisted Livery

Cost: £70.00 p/week

The Assisted Livery Package offered by The Daimler Foundation includes (every AM):

- Horse mucked out
- Horse turned out in field (Weather permissible)
- Haylage
- Feeds put in
- Use of Wash Bay (Solarium not included)

It is your responsibility to look after your horse(s) every evening before yard closing hours unless prior arrangements have been made with at least 2 days' notice. You will be expected to supply your own shavings and feeding.

3.3 Premier Shows

For a few events in the calendar year, you may have to move your Horse to a temporary stable (still on the premise) for the maximum of 1 week. You will be notified of these dates at least 2 months prior to the event. There will be no reduced fees or discounts during this time.

3.4 Extra Fees

Below is a list of extras we can provide and their fees.

3.5 Benefits

After **1 month** from the date your Livery began, as a thank you for stabling your horse with us at The Daimler Foundation we would like to offer you the below benefits:

- Free membership to the Riding School
 - Discounted riding lessons from our Riding School
 - Discounted entry fees for unaffiliated competitions
- 10% discount from First Saddlery
- 10% discount in our Café and Restaurant

4. Veterinary Surgeon

The customer may employ a Veterinary Surgeon of their choice.

However, in the event of an emergency, the Veterinary Practice used by the Yard may be summoned. The yard reserved the right to contact the vet at their discretion, the cost of the visit and subsequent treatment will be the responsibility of the Customer.

5. Farrier

The customer is solely responsible for the care and cost of horses shoeing needs and can employ the farrier of their choice.

6. Insurance

The yard, nor the proprietor, is not responsible for ensuring the Horse or any other property of the customer is insured. The yard strongly advises that adequate insurance is taken out by the Customer for their Horse(s) and property. Riders are also recommended to insure themselves against personal accident and liability.

7. Limitations of Liability

Death or personal injury caused by negligence of the Yard or anyone for whom in the law the Yard is responsible, neither the Proprietor nor any agent, employee or representative of the Yard accept any liability for any accident, loss, damage, injury or illness to horses, owners, riders, visitors or any other person or property whatsoever caused.

Without prejudice to the generality of the foregoing the Yard will not be responsible for any loss out of injury or damage to the horse where the Customer has not notified the Yard in writing of any requirements of the Horse.

No children under the age of 16 may be left at the Yard without at least one parent or under the supervision of a responsible adult without prior agreement in writing with the Yard for the duration.

Customers are not permitted to bring dogs to the Yard.

Any damage caused at The Daimler Foundation by yourself, your horse, your property, or your visitors will be your responsibility and you will be required to pay for the repairs.

8. Safety, Fire, First Aid, Health & Safety Policy

These conditions apply to all customers of the Yard.

- No Climbing on machinery, shavings, hay or haylage bales.
- First Aid Boxes and Accident Books are held within the Riding School, Bar & Restaurant, Show Office, and Main office.
- Riding hats **must** be worn whilst riding anywhere on the premise.
- All accidents must be reported, and the accident book filled in for both person(s) and Horse(s).
- Smoking is allowed, please use designated smoking points outside building. Anyone caught smoking inside the building may have their contract revoked and asked to leave the premise.
- All customers are requested to be clean and tidy when using the facilities at the Yard. i.e. close gates put away what you use and clean up after yourself.
- Please turn off stable and arena lights after use.
- We do not allow the use of third-party instructors. If required, this service can be provided by the Yard.
- Cars and Horseboxes etc. must always be parked safely and locked. The Yard accepts no liability for cars parked on the premises.
- Please do not block any entrances/exits.
- The Yard does not accept responsibility for any accidental injury or health problems for individual Horses or the loss of any private property. Clients are strongly advised to have individual accident/ health / third party and property insurance.
- No running/ball games/ shouting or entering other Horse(s) stables that do not belong to you.

9. Payment

9.1 Deposit

To secure your livery at The Daimler Foundation, you must supply one month's livery upfront as a deposit. This deposit will be refunded upon the contract being revoked by either party.

9.2 Monthly Fee's

You will receive an invoice each month detailing what remuneration is due. You will be expected to pay the invoice by the last day of the month via BACs Transfer.

10. Changes to the Contract

Over the course of time livery is offered at The Daimler Foundation, there may be some changes necessary to the terms and conditions of this contract. In the case that there are any changes to be made, you will be made aware at least one month before these changes come into effect. Should this not be paid on time, your contract may be terminated to avoid falling behind with your livery bill.
